How to Find a Docket

DOCKETS

The PUCN assigns a docket number to all new filings (applications, petitions, rulemakings, investigations, etc.) to make them easier to track

After a docket number has been assigned, all subsequent documents filed by any party (such as comments or testimony) or issued by the PUCN (such as notices and orders) in the course of the proceedings are identified by the same docket number and can be located using the docket number.

DAILY FILINGS REPORT & WEEKLY NOTICE SUMMARY

The Daily Filings Report and Weekly Notice Summary can be viewed on the <u>PUCN Document Search site</u>. Both reports can help you find dockets you may be interested in following. To stay informed of all notices and orders issued in dockets that interest you, sign up for the docket's service list (see **SERVICE LISTS** below.)

- For the **Daily Filings Report**, change the "Search Type" to "PUC Public Search Daily Filings Report."
- For the **Weekly Notice Summary**, change the "Search Type" to "PUC Public Search Weekly Notice Summary."

ALTERNATE SITE TO LOOK UP DOCKETS

Use the PUCN's legacy <u>PUCN All Dockets</u> web page to find a docket. The "CTRL + F" search function allows for a keyword lookup for a company or a regulation topic.

Example: Search for "rate case" to find the docket number associated with NV Energy's latest rate case (Docket 25-02016). Then head to the <u>PUCN Document Search site</u> and enter the docket number in the "Docket Number" field to view documents filed in the case.

Docket Numbers Explained

In the example below, the docket is numbered 25-05014 - meaning it was the 14th docket opened in May 2025. Knowing the year a docket was opened can help in the search for information.

year docket opened in 2025

month docket opened in May 2025

SERVICE LISTS

Master Service List: receive email notification of new dockets opened by utility type, utility company, or area of interest (ie, renewables).

✓ **Docket Service List:** receive email notification of all notices & orders issued in specified dockets.

Public Meeting Notice: receive email notification of PUCN Agenda Meetings.

Instructions Use an Asterisk to broaden your search Example. Enter 3 letters of a company name or the first 3 digits of a docket number followed by an asterisk.
