# Wildfire Awareness Campaign: May - October

Wildfire can threaten Nevadan communities and impact homes, property and human life. One key to minimizing the wildfire risk in Nevada is for communities to be proactive and take steps to prepare and become fire adapted.



In response, representatives of Nevada's local, state, and federal firefighting agencies; wildfire-prone communities; and the University of Nevada, Reno Extension have conducted an annual wildfire awareness campaign since 2006. Wildfire can threaten Nevadan communities any time of the year. This year's campaign is extended from May – October 2021.

Here are some general tips to help you to prepare and become fire adapted:

 Keep the first five feet away from your home free of combustible materials such as wood, mulch, dried leaves,

# Natural Disaster Preparedness & Electric Utilities

The 2019 Nevada Legislature passed <u>Senate Bill 329</u> (SB 329) requiring electric utilities in Nevada to submit a natural disaster protection plan (NDPP) to the PUCN every third year beginning on or before March 1, 2020. The NDPP must outline procedures and protocols relating to the efforts of the electric utility to prevent or respond to a fire or other natural disaster.

On June 6, 2019, the PUCN opened an investigation and rulemaking to implement SB 329. The matter was designated as Docket No. 19-06009.

After receiving comments from many stakeholders and holding several workshops, on Jan. 30, 2020, the Commission adopted regulations contained within Chapter 704 of the Nevada Administrative Code.

The regulations include the following, among other, requirements for NDPPs:

- Identification of areas within the service territory of the electric utility that are subject to a heightened threat of a fire or other natural disaster.
- A description of the preventive strategies and programs, including, without limitation, operational practices, inspections and corrections, and system hardening that the electric utility will adopt to minimize the risk of its electric lines and equipment causing catastrophic wildfires.
- The protocols that the electric utility plans to use for disabling reclosers and de-energizing portions of the utility's distribution and transmissions system that



pine needles and or pavers.



Complete a home inventory, prepare

an evacuation plan for you and your household and prepare an evacuation Go-Bag.

Connect with your neighbors to encourage community

projects to help reduce the wildfire threat, and register your home and cell phones for your local emergency response system (often called reverse 9-1-1.)

- Check areas where burning embers might accumulate on your property during a wildfire. The places where the leaves pile up also tend to be where embers would too during a wildfire. Remove any easily ignited materials such as dried grass, leaves, needles and debris from your rain gutters. Inspect structures for any necessary improvements to prevent ember entry.

considers the associated impacts on public safety.

- A description of the procedures the electric utility intends to use to restore its distribution and transmission system in the event of the de-energization of those systems or a portion of those systems.
- A communication plan related to public safety outage management, which includes, without limitation, plans to communicate with customers, stakeholders and communication infrastructure providers.
- A description of the standard for vegetation management to be used by the electric utility.
- An electric utility shall separately track and account for all prudent and reasonable expenditures made by the electric utility to develop and implement its NDPP.

On or before March 1 of each year, an electric utility shall submit to the Commission an application to recover the cost of prudent and reasonable expenditures made by the electric utility during the immediately preceding year to develop and implement the NDPP.

The Division of Staff Legal Counsel is responsible for providing legal counsel and support to Staff.

Staff Counsel's duties include formulating legal strategy and legal positions regarding utility filings; drafting case discovery; and preparing pleadings, briefs, responses to petitions, stipulations, and other filings applicable to the regulation of Nevada utilities.

Staff Counsel also reviews and assists in the development of Staff testimony and filings; ensures that Staff's positions

are in compliance with Nevada statutes and regulations; represents Staff at PUCN hearings and workshops; assists in the development of proposed regulations and legislation; and provides other legal support to Staff divisions.

Staff Counsel is the only division within Staff that addresses, in some form, every case filed with the PUCN.
