#### **Winter Natural Gas Bills**

The cost of natural gas is rising and Nevadans may be feeling it in their winter utility bills. The reason for the rising costs is global and not just unique to Nevada.

Southwest Gas provided the information below to help explain the increase.

- Supply/demand imbalance combined with the residual effects of winter storm Uri have put upwards pressure on gas prices.
- Current US natural gas demand is well above available supply.
  - \* Early in the pandemic, overall demand was reduced due to lockdowns and caused decreased drilling.
  - ★ In 2021, increased worldwide economic activity drove an increase in demand.
  - In 2022, the Russian invasion of Ukraine increased demand for US Liquified Natural Gas.
  - US Liquified Natural Gas exports are up close to 50% from where they were in 2021.
  - Lagging US production means that supply is not able to keep up with domestic and worldwide demand for US Liquified Natural Gas.
  - Supply and demand are not currently balanced, which is driving up prices.

The price consumers are charged monthly for natural gas is updated quarterly, which could mean an increase on your bill if the cost of natural gas increased.

Natural gas and electric utilities provide notice of any upcoming rate changes through inserts in monthly bills and on the utilities' websites.

Nevada law does not allow utilities to profit on the cost of natural gas. Utilities must pass the cost on to consumers on a dollar-for-dollar basis.

#### **TIPS TO HELP WITH WINTER UTILITY BILLS**

Southwest Gas provides the tips below to help consumers mitigate the rising cost of natural gas.

 Set the daytime thermostat between 65°F and 68°F, health permitting, and the nighttime temperature at a lower setting. Every degree that a heating system is adjusted affects its daily energy use and, in turn, a customer's energy bill.

- Regularly change or clean air filters as required. Heating units use less energy and work more efficiently when filters aren't clogged or dirty.
- Kitchens are particularly vulnerable to excessive warming, especially from the extra heat generated by cooking. Adjust the kitchen vents, if you have them, until the room is comfortable.
- To help keep warm air inside the home and the cold air out, seal leaks and cracks around doors, windows and other openings with caulk or weather stripping. Proper insulation and sealants can help save up to 20 percent on heating costs annually.
- Curbing the use of non-essential natural gas features, including pool and spa heaters, Tiki torches or other decorative fire features, can help conserve natural gas.
