## PUCN Agenda Meetings - Where Decisions Are Made

### AGENDAS EXPLAINED

All decisions concerning privately-owned water, wastewater, electric, and natural gas utilities in Nevada are decided at Agenda meetings, also known simply as "Agendas." These meetings follow a formal agenda, adhere to [Nevada Open Meeting Law](#), and cover such topics as rate changes, new regulations, formal investigations, and petitions filed by PUCN staff, utilities, or other parties.

### NOTICE OF AGENDA

The PUCN publicizes an upcoming Agenda through a Notice of Agenda. The Notice includes a list of dockets that will be decided at the meeting. Dockets not listed on the Notice cannot be considered.

The Notice is published online to the [PUCN Document Search](#) site five days prior to a scheduled Agenda meeting to allow the public ample time to see which dockets will be discussed and decided.

### PUBLIC MEETING NOTICE SERVICE LIST

The public may sign up for the PUCN's [Public Meeting Notice](#) service list to receive email notification when a Notice of Agenda is published.

### LONG BEFORE AN AGENDA TAKES PLACE

Long before a docket is scheduled to be decided at an Agenda, evidentiary hearings or workshops have taken place over the course of several months. These proceedings are videoconferenced between the PUCN's Las Vegas and Carson City offices and are open to the public. They can also

be streamed live on the PUCN website.

Witnesses, including PUCN experts, company executives, engineers, economists, and consumer advocates, testify under oath. Attorneys cross-examine witnesses to test the accuracy and reliability of their statements.

Every document and exhibit submitted by the utility and witnesses, and admitted by the docket's presiding officer, become part of a docket's official record, all of which is posted and available for public viewing on the [PUCN Document Search](#) site.

### COMMISSIONERS DELIBERATE & DECIDE

At an Agenda, Chair Hayley Williamson, Commissioner Tammy Cordova, and Commissioner Randy Brown discuss, deliberate, and make decisions on each docket listed on the Notice of Agenda. A motion to deny, approve or amend an order must have at minimum two commissioner votes to pass.

The commissioners are legally required to base their decision solely on the sworn, cross-examined record. They cannot consider rumors, personal opinions, or last-minute arguments outside the formal evidence.

### PUBLIC COMMENT & OBSERVANCE

Agendas are open to the public and can be streamed live on the PUCN website. Members of the public may offer brief comments—typically limited to two or three minutes per speaker.

# How to Find a Docket on the PUCN Website

## DOCKETS

The PUCN assigns a docket number to all new filings (applications, petitions, rulemakings, investigations, etc.). The docket number serves as a unique identifier for the matter.

After a docket number has been assigned, all subsequent documents filed by any party (such as comments or testimony) or issued by the PUCN (such as notices and orders) in the course of the proceedings are identified by the same docket number and can be located using the docket number.

## DAILY FILINGS REPORT & WEEKLY NOTICE SUMMARY

The Daily Filings Report and Weekly Notice Summary can be viewed on the [PUCN Document Search site](#). Both reports can help you find dockets you may be interested in following. To stay informed of all notices and orders issued in dockets that interest you, sign up for the docket's service list (see **SERVICE LISTS** below.)

## ALTERNATE SITE TO LOOK UP DOCKETS

Use the PUCN's legacy [PUCN All Dockets](#)\* web page to find

a docket. The "CTRL + F" search function allows for a keyword lookup for a company or a regulation topic.

Example: Search for "rate case" to find the docket number associated with NV Energy's latest rate case (Docket 25-02016). Then head to [PUCN Document Search](#) and enter the docket number in the "Docket Number" field to view documents filed in the case.
