## Fix A Leak Week (March 20-26)

#### PUCN supports EPA's efforts to find and fix household leaks

The annual Fix a Leak Week campaign sponsored by the U.S. Environmental Protection Agency (EPA) WaterSense Program is scheduled for March 20-26.

The Public Utilities Commission of Nevada (PUCN) supports the event and urges Nevadans to help put a stop to household water leaks that the EPA estimates account for nearly 1 trillion gallons of water wasted nationwide each year – an amount equal to the annual household water use in nearly 11 million homes.

The PUCN encourages consumers to take a few simple steps that can add up to a significant positive impact. Fixing easily-correctable household water leaks can save homeowners about 10 percent on their water bills, according to the EPA.

"Household leaks can account for more than 10,000 gallons of water in an average home every year. 10 percent of homes have leaks that waste 90 gallons or more a day," PUCN Water Engineer Cindy Turiczek said.

Common types of leaks found in the home are worn toilet flappers, dripping faucets, and other leaking valves. These types of leaks are often easy to fix, requiring only a few tools and hardware.

"Old and worn faucet washers and gaskets frequently cause leaks in faucets. A leaky faucet that drips at the rate of one drip per second can waste more than 3,000 gallons per year. That's the amount of water needed to take more than 180 showers," Turiczek added.

#### EPA'S FIX A LEAK WEEK TIPS INCLUDE:

• <u>Check for leaks.</u> Look for dripping faucets, showerheads, and other fixtures. Don't forget to check irrigation systems and spigots too. Look at your water usage during a colder month. If a family of four exceeds 12,000 gallons per month – there are serious leaks.



- <u>Toilet leaks.</u> Identify toilet leaks by placing a drop of food coloring in the toilet tank. If any color shows up in the bowl after 10 minutes, you have a leak. Be sure to flush immediately after the experiment to avoid staining the tank.
- <u>Replace the fixture if necessary.</u> Look for WaterSenselabeled models, which are independently certified to use 20 percent less water and perform as well as or better than standard models. In many cases, fixture replacement parts pay for themselves quickly and can be installed by do-it-yourselfers or plumbing professionals. Irrigation professionals certified through a WaterSense-labeled program can also check systems for leaks.

# DETECT AND CHASE DOWN LEAKS



#### **Start by Gathering Clues**

These clues can help you detect leaks before you even start investigating your home.



#### **Check Your Utility Bill**

A place to start is to examine your utility bill for January or February. It's likely that a family of four has a serious leak problem if its winter water use exceeds 12,000 gallons (or 16 CCF) per month. You can also look for spikes—is your water use a lot higher this month than it was last month? Learn more about your water bill:

#### **Read Your Water Meter**

Find your water meter, which is usually near the curb in front of your home but can be inside your home (e.g., in the basement) in cold climates. Use a screwdriver to remove the lid on your meter, which is heavy and usually marked "water."

Now that you've found the meter, take a reading during a period when no water is being used. If the meter does not read exactly the same after two hours, you probably have a leak. Here's a tip on how to read a water meter:

#### Take a Toilet Test

Put a few drops of food coloring into the tank at the back of your toilet and let it sit for 10 minutes. If color shows up in the bowl, you have a leak. Make sure to flush afterward to avoid staining, and consider replacing your old toilet flapper if it is torn or worn. Check our Fix a Leak web page for handy videos that show you how to do it.
