May is Nevada Wildfire Awareness Month

Wildfires are not uncommon in Nevada. Forests in the Lake Tahoe area in the north and the Spring Mountains in the south have experienced wildfires that cause destruction to not just the forests, but to people living in the area and the utility infrastructures that serve them.

According to Living with Fire's (LWF) website, <u>livingwithfire.org</u>, the combination of strong winds, dry vegetation and low humidity result in a fire that is "more difficult to contain when these conditions are present." There is an abundance of strong winds, dry vegetation and low humidity in Nevada!

LWF is a Nevada collaboration of federal, state, and local firefighting agencies working to educate and prepare Nevadans to keep homes and communities safe from wildfires.

Since 2019, the Nevada Legislature has required NV Energy to have a Natural Disaster Protection Plan (NDPP) in place to help reduce the chances that electrical equipment might contribute to or cause a wildfire. Measures such as cutting vegetation near overhead power lines and de-energizing lines during high winds are just a few of the tools used by the utility in its NDPP.

The NDPP, which must be submitted to the PUCN for approval, must include the following elements:

- (a) Areas within the utility's service territory that are subject to a heightened threat of a fire or other natural disaster.
- (b) An approach for the mitigation of potential fires or other natural disasters that is cost effective, prudent and reasonable.



Every May, Living With Fire (LWF) partners with agencies across Nevada to create a vital interagency wildfire education campaign aimed at raising awareness and preparedness across the state.

(d) The participation of the utility, including any commitments made, in any community wildfire protection plans, as defined in 16 U.S.C. § 6511, established in this state.

(e) Protocols for de-energizing distribution lines and disabling reclosers on those lines in the event of a fire or other natural disaster. Such protocols must consider the associated impact of such actions on public safety and mitigate any adverse impact on public safety plans, including the impact on critical first responders and on health and communication infrastructure.
(f) The procedures to inspect the utility's

(f) The procedures to inspect the utility's electric infrastructure.

- (g) The procedures the utility intends to use for vegetation management.
- (h) The procedures the utility intends to use to restore its distribution system in the event of a natural disaster.
- (i) Demonstrate that the natural disaster protection plan is consistent with the emergency response plan submitted by the utility pursuant to NRS 239C.270.
- (j) Describe the ability of the utility to implement the natural disaster protection plan and identify additional funding needed for the implementation of the plan.

PUCN Consumer Sessions Allow Citizens to Be Heard

About Consumer Sessions

There are two types of consumer sessions: general consumer sessions and case-specific consumer sessions.

Case-Specific Consumer Sessions: The PUCN must conduct consumer sessions when a public utility files a general rate application; an application to recover the increased cost of purchased fuel or natural gas purchased for resale; an annual deferred energy accounting adjustment application; or an annual rate adjustment application. A consumer session is also held if an application will result in an

as well as some telecommunication, railroad and water companies. The record from the consumer sessions is provided to the Legislature.

What to Expect at a Consumer Session

All PUCN consumer sessions are free and open to the public. PUCN staff facilitate the consumer session by greeting attendees, signing up those who wish to speak and answering questions about the process. In addition to members of the PUCN, representatives from the Nevada Bureau of Consumer Protection and the utilities are often available to respond to consumer concerns.

Speakers may be limited to five

increase in annual gross operating revenue in an amount that will exceed \$50,000 or 10 percent of the applicant's annual gross operating revenue, whichever is less. The PUCN may hold additional case-specific consumer sessions, although not required to do so by statute. Case-specific consumer sessions offer a forum for the public to voice opinions about the filing directly to PUCN commissioners and staff.

 General Consumer Sessions: Each calendar year, the PUCN must conduct at least one general consumer session in the county with the largest population (Clark) and in the county with the second largest population (Washoe). General consumer sessions allow the public to provide input about any topic concerning utilities regulated by the PUCN, including NV Energy and Southwest Gas, minutes at the discretion of the PUCN chairman or presiding officer of the case depending on the number of speakers. A court reporter provides transcription services for the official record or the meeting is tape recorded and later transcribed.

Consumer Session Announcements

Information about when and where consumer sessions are held is publicly noticed in local newspapers, available on the PUCN's website, in inserts in your monthly gas, water, wastewater and electricity bills, or by contacting PUCN offices in Las Vegas or Carson City.
