The PUCN monitors, collects, audits and disburses assessments that support the Nevada Energy Assistance and the Nevada Weatherization Assistance programs, but does not administer them. Below is information on several programs that may be helpful to you or someone you know.

### ASSISTANCE FOR SENIORS & DISABLED CUSTOMERS
