## Multiple Consumer Sessions Scheduled in June

Consumers will have the opportunity to voice their opinions at several PUCN consumer sessions scheduled in June.

All PUCN consumer sessions are free and open to the public. PUCN staff facilitate by greeting attendees, signing up those who wish to speak, and answering questions about the process. Speakers may be limited to three minutes depending on the number of speakers. A court reporter provides transcription services for the official record or the meeting is tape recorded and later transcribed.

If the city in the list below is "Video," the consumer session will be held at the PUCN's offices in both Carson City and Las Vegas and will be videoconferenced between the two locations. Consumers may appear and comment from either location.


## **Create & Manage Your 811 Tickets Anywhere - Right from Your Phone!**


With the FREE <u>Underground Service Alert of Northern</u>
<u>California & Nevada</u> (USAN) mobile app, excavators can create and manage tickets quickly and easily from the field.


USAN is Nevada's 811 call center. When you call 811, a USAN representative will help you submit your 811 "dig ticket." Within two business days, the electric, natural gas, sewer, water, and telecommunications utilities in your area will send locators to mark with paint the location of underground utilities near your proposed excavation site.

Dig ticket requests can also be submitted online at <u>usanorth811.org/</u>, and now also through USAN's mobile app.
